

She will however, be liable for the articles issued to him and not handed over/found short.



1. She will not be regular employee of the University and will not be entitled to claim regular pay scale of post or any other benefits. The University would not be bound to re-employ her on contract after completion of the above term.
2. She would be entitled to casual leave only proportionate to the period for which she is appointed, taking 20 days leave, as the norm for one calendar year.
3. Her contract services will be terminable at any time on 10 days notice in case of financial stringency, unsatisfactory work or conduct. She can also quit on 10 days notice on either side or payment of 10 days consolidated emoluments in lieu thereof.
4. She will be required to produce a Medical Fitness Certificate from Senior Medical Officer, CCSHAU, Hisar, before she is allowed to join.
5. For journeys undertaken in connection with the official work, TA will be admissible as per entitlement of the post against which the re-employment on contract is given.
6. She will be required to sign an agreement bond on non-judicial stamp paper of Rs. 15/- on the prescribed format before she is allowed to join.
7. No benefit of CPF/GPF will be admissible during the tenure of re-employment on contract.
8. She will be required to join the post within a period of 15 days from the date of issue of the order, failing which the offer may be treated as withdrawn.


